LAYOUT NOTES

1. VERIFY DIMENSIONS AND ACCEPT CONDITIONS BEFORE PROCEEDING WITH ANY WORK. REPORT DISCREPANCIES TO LANDSCAPE ARCHITECT.
2. DIMENSIONS TO CURBS AND WALLS ARE TO EXPOSED FACES UNLESS NOTED OTHERWISE.
3. SEE ELECTRICAL DRAWINGS FOR LAYOUT OF SITE LIGHTING.
4. SEE UTILITY DRAWINGS FOR TRENCH BACKFILLING AND SURFACE REPAIRS NOT SHOWN ON THIS DRAWING.
5. SEE ARCHITECTURAL DRAWINGS AND PLUMBING DRAWINGS FOR HOSE BIB LOCATIONS.
6. INSTALL ISOLATION JOINTS IN CONCRETE PAVING ABUTTING CURBS, STEPS AND OTHER FIXED OBJECTS.
7. CONCRETE SCORING IS BASED ON THE MODULE SIZE INDICATED. ADJUST AS NECESSARY TO MATCH FIELD CONDITIONS.
8. INSTALL COURSES OF CONCRETE UNIT PAVERS WITH WHOLE OR HALF UNITS TO THE EXTENT POSSIBLE. DO NOT INSTALL UNITS NARROWER THAN 8".
9. FIRELANE SIGNAGE LOCATIONS TO BE CONFIRMED WITH THE OWNER AND ARCHITECT PRIOR TO INSTALLATION.
10. LOCATIONS OF LITTER AND RECYCLING RECEPTACLES TO BE CONFIRMED WITH ARCHITECT PRIOR TO INSTALLATION.
